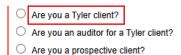
Requesting a New SOC Report

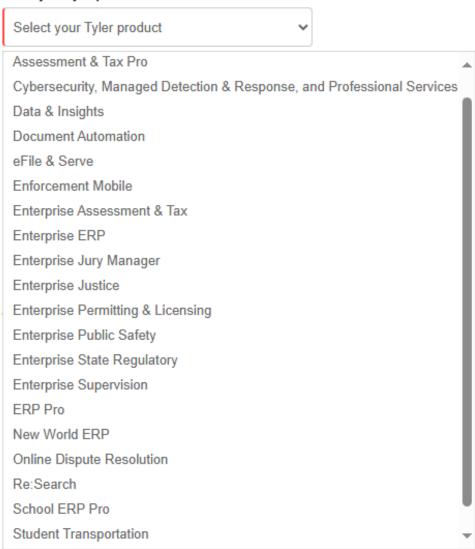

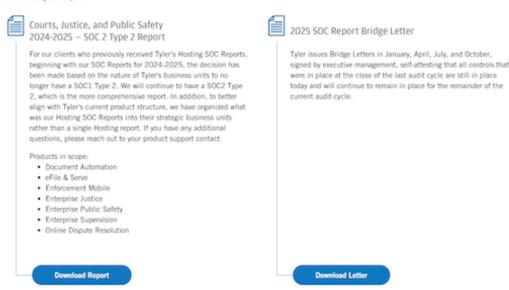

To obtain a copy of the Tyler Technologies SOC Reports, please complete the following steps:

- 1. Download a copy of the <u>Tyler Technologies Confidentiality & Non-Disclosure Agreement</u> (NDA) for Prospective Clients
- 2. Have a person authorized by your organization to sign legal agreements on the organization's behalf complete and sign the bottom-right section of the NDA. The "Recipient" line in the signature section is for the name of your organization as the agreement is between Tyler and that organization, not with an individual.
- Send the signed and completed NDA to <u>NDAVerification@tylertech.com</u>. Please include the Tyler product(s) that your organization is considering purchasing to ensure that the properly scoped reports are provided.
- 4. Once it has been verified that the NDA has been correctly completed and signed, an email with a link to download the SOC Reports will be sent by our Security Team to the email address of the person requesting the reports, unless an alternate recipient and their email address are provided.
- 5. Click the **Download** link in the email which will bring you to the login page for Tyler's Secure File Transfer Utility.
 - If you are a registered Kiteworks user, log in using your existing credentials.
 - If you do not have an account, enter your email address and follow the instructions to create an account.
 - i. **Note:** To create an account, you must use the same email address as the one the link to download the SOC reports was sent.
 - After logging in, click Download report and save the .ZIP folder to your desired location.

External Auditors for Tyler Clients

- 1. Select 'Are you an auditor for a Tyler client' to generate step-by-step instructions to request a SOC report. See the same instructions copied below for reference.
- 2. Download a copy of the <u>Tyler Technologies Confidentiality & Non-Disclosure Agreement</u> (NDA) for Auditors.
- 3. The bottom-right rection of the NDA must be completed by a representative authorized to sign legal agreements on your organization's behalf.
 - a. **Note:** The "Recipient" line in the signature section is for the name of your firm (as the agreement is between Tyler and that organization, not with an individual).
- 4. Send the **signed and completed NDA** to <u>NDAVerification@tylertech.com</u> for countersignature. Please include the Tyler products that your client is using to ensure that the properly scoped reports are provided.
- 5. Have your client send an email to NDAVerification@tylertech.com authorizing your firm to receive the SOC reports on their behalf. The link to download the reports will not be sent until we have received the client's authorization.
- 6. After the NDA has been verified and countersigned and the client's authorization is received, Tyler's security team will send an email including the link to download the SOC reports to the email address of the person requesting the reports, unless provided with an alternate recipient and their email address.
- 7. Click the **download link** in the email to download the report, which will transfer you to Tyler's Secure File Transfer Utility.
 - a. If you are a registered Kiteworks user, log in using your existing credentials.
 - b. If you do not have an account, enter your email address and follow the instructions to create an account.
 - i. **Note:** To create an account, you must use the same email address as the one the link to download the SOC reports was sent.
 - c. After logging in, click **Download report** and save the .ZIP folder to your desired location.
 - d. To open the report, extract the PDF file from the .ZIP folder.
