The Leon County Property Appraiser's Office is located in Florida's capital city of Tallahassee. Named after Spanish explorer Juan Ponce de León, Leon County is also home to two major universities — Florida State and Florida A&M — and more than 20,000 state employees. That means that the property appraiser's office serves a large population of highly educated, technically proficient and time-challenged constituents.

Many constituents had difficulty finding time to stop by the single, downtown property appraiser's office to drop off forms or stand in line. Because many property owners were technologically savvy, Leon County knew they needed an online solution to add convenience to the form-filing process. The next step was to contact Tyler Technologies.
